# **RESEARCH PROJECT**

# **ENVIRONMENT**

This 3-Year-long doctoral fellowship is offered as part of a specific collective project within a multiannual international research effort on Globalisation, Europe, and Multilateralism (GEM). This project (2022-2026), coordinated by the Institut d'études européennes (IEE) at the Université libre de Bruxelles (ULB), will assess the EU's capacity to act given the challenges facing Democratic Institutions, the rise of Alternative MOdels and mounting Normative Dissensus (DIAMOND).

**GEM-DIAMOND** is a *Marie Skłodowska Curie Action - Doctoral Network* (MSCA-DN) involving 7 European and 4 international degree-awarding Higher Education Institutes (HEIs) alongside 6 well-established non-academic institutions. The project will hire and train 16 doctoral fellows to help address knowledge gaps associated with the growing normative tensions undermining multilateral and democratic practice – for further information see www.gem-diamond.eu.

GEM-DIAMOND's overall research program will collectively tackle three shared knowledge gaps regarding contemporary strains on liberal democracy:

- **Objective 1:** Conceptualising the seemingly mounting dissensus surrounding liberal democracy.
- **Objective 2:** Unpacking the ambiguous role different actors can play as both champions and challengers of liberal democratic norms, values and practices.
- **Objective 3:** Assessing the impact of increased dissensus regarding liberal democracy on the policy instruments of the EU and its capacity to act in its internal and external policies.

Early-Stage Researcher n°12 (**ESR12**) is part of **GEM-DIAMOND**'s 3<sup>rd</sup> Work Package (WP3) entitled 'Internal contestation and its impact on the EU'. WP3 includes 5 individual doctoral projects that will each develop a detailed analysis of a given case study elucidating the processes by which contestation regarding liberal democracy shapes the EU's capacity to act.

Both individually and collectively, the 5 PhD fellows associated with WP3 will produce detailed analyses of a range of case studies. These will elucidate the processes by which contestation regarding liberal democracy shapes the EU's capacity to act. The five PhD fellows involved will adopt a process-centric approach, with each Researcher working on a different type of EU policy instrument. Ultimately, WP3 will **process-trace the institutional mechanisms connecting evolutions of the EU's regulatory, parliamentary, legal and trade instruments with the internal contestation shaping these controversial policy fields.** 



# INDIVIDUAL RESEARCH PROJECT (IRP)

Entitled 'Contesting European border regimes: challenging and remaking EU migration governance' the individual research project of **ESR12** is in the fields of Border and Migration Studies, **International Relations, Mediterranean and Middle Eastern Studies** and **European Studies** 

**ESR12** will focus on practices which sustain the EU's border regimes with third countries in the Mediterranean, including 'compacts', partnerships, and bilateral agreements. The ESR will examine how such practices (that comprise forms of detention, deportation, and pushbacks, as well as the use of surveillance technology) contest the EU's liberal values and norms.

Successful candidates can design a project of their own choosing focusing on new and on-going forms of externalisation of the EU's and Member States' border and migration policies in the Mediterranean and wider MENA region. Possible topics can include, though are not limited to migration and mobility partnerships, EU-wide as well as bilateral; practices which sustain border regimes; the role of NGOs, IOs or courts; datafication and digitalisation of migration governance; the contestation of these practices, including by migrants and from an intersectional perspective.

As part of their application, candidates will be asked to submit a personal interpretation of the research project in the form a specific project proposal of 2-3 pages, including a research question, a theoretical framework, a methodological strategy, and a justification for the suggested empirical choices.

- Individually work towards a double doctoral degree in 'Political and Social Sciences' under the joint supervision of Pr. L. Bialasiewicz (UvA) and Pr. J. Jeandesboz (ULB)
- Contribute to the collective work in WP3 seeking to describe the processes of contestation within the EU by focussing on contested practices
- Participate in all collective research and training activities and submit to the program's regular joint evaluations

# DEGREE

Top level graduate degree (Master or equivalent providing access to PhD programs in Political or Social Sciences, Area Studies or Border and Migration Studies).



# MINIMAL CREDITS

Applicants must submit at least one diploma meeting one of the following requirements: (1) a two-year master program (120 ECTS) or equivalent, (2) a one-year graduate program following a prior undergraduate degree if both diplomas total at least 300 ECTS or equivalent; (3) a single four-year higher education program offering 300 ECTS or more.

# LANGUAGE

English proficiency must be attested either through a previous English language diploma, or an internationally recognised proficiency test (i.e. IELTS, IBT, TOEFL or Cambridge).

#### CAREER

The researcher should be in the first four years of their research careers at the time of recruitment and have not been awarded a doctoral degree so far.

# SPECIFIC SKILS

Successful candidates should possess the necessary language skills to carry out research in the country/countries in question. Some familiarity with field work research methods and qualitative methodologies will also be considered a plus.

#### MOBILITY

At the time of recruitment, the researcher must not have resided, or carried out his/ her activity in the country of the first host institution (i.e., Netherlands) for more than 12 months cumulatively in the 3 years prior to October 2022
