Relations between Latin America and Europe, as well as their own regional dynamics, are embedded in an ever more complex global system that is undergoing fundamental changes. Global reordering, emerging powers, and reconfigurations in the economic and political landscapes bring old and new challenges to the international level. International trade, global value chains, financial flows, and developmental gaps are challenging global, regional, and inter-regional relations. Environmental degradation and climate change are posing existential threats to the planet. The commitment to achieving the Sustainable Development Goals is declining. Great power competition and, in particular, the growing US-China rivalry are creating new fault lines in global politics.

In July 2023, the EU-CELAC Summit fostered bi-regional cooperation on areas such as enhanced cooperation in multilateral for a; global peace and security; trade and investment; efforts to combat climate change; justice and security for citizens. At the same time, European links with Latin America are indissociable from and significantly impacted by the ‘other’ transatlantic relation, between Europe and North America and the United States. Arguably, these three regions form a dense web of relationships and connectivities in and around the Atlantic Ocean amidst a global reordering that shifts the global ‘centre of gravity’ towards the Pacific Ocean and the so-called Indo-Pacific.

Against this backdrop, the Department of International Relations at FLACSO Argentina, in association with the Jean Monnet Policy Network EU-RENEW (<https://eu-renew.eu/>), welcomes your to the Conference ***Latin America-Europe Relations in Global Reordering***. The conference aims to explore the complexities of the relationship between Latin America and Europe, and to examine how this bi-regional relationship is shaped by the changing global landscape. Interested scholars from across disciplines are invited to submit proposals for papers to be presented at the general conference.
