Dear Colleagues,
Dear GEM Alumni,
Dear Friends,

Before considering GEM-DIAMOND's 1st Annual Conference which has us return to Brussels once more, allow us to first take a moment to reflect on the enormous contribution the recently departed Professor Mario Telò made to our community.

It was indeed with great sadness that we all learned of his sudden passing only days before we were scheduled to gather for this conference. As the founding father of the GEM community, Mario provided the initial spark and much of the drive that would allow for GEM to see the light of day and develop into the thriving global community it has become in just over two-decades.

An academic force of nature, Mario's resolute dedication to the study and further development of European institutionalism, his steadfast commitments to multilateralism and cosmopolitanism, as well as his continued enthusiasm for mentoring successive generations of scholars in political theory, international relations and European studies all conspired to see him leave a sizeable imprint on almost all members and aspects of the GEM/GEM-STONES/GEM-DIAMOND community. His departure indeed leaves our community bereft of an intellectual dynamo driven by a curious mind, a generous heart and an unbreakable belief in the salutary nature of institutionalised multilateral

cooperation.

Whether at this year's annual conference, or over the coming months, several opportunities will present themselves to remember and acknowledge Mario's many contributions. In particular, the scheduled publication of his last monography - Multilateralism Past, Present and Future: A European Perspective (Routledge: 2023) - will provide a privileged opportunity to revisit some of his work. In this respect, we are committed to making sure all the GEM community is informed of, and where possible associated with, any future initiatives.

The hope is that, as our collective work goes on, we will continue to bear in mind what Mario has meant for the community and its individual members. It was barely six-months ago that we gathered in Brussels for the GEM-DIAMOND kick-off marking the third iteration of this continuously evolving research agenda on Globalisation, Multilateralism, and Europe. In this all by all relatively short period of time, a lot has already happened.

At the individual level, fellows have settled into their respective starting institutions across the continent. We are acutely aware that this has been a more or less taxing experience for different members of the community. While much of the constraints and challenges when expatriating from one country to the next are beyond the control of the consortium and its individual members, we will continue to make a point of monitoring - with the help of the partner institutions and the project management office - the respective fellows' individual situation as closely as possible.

Now that we have formally confirmed all fellows have fully integrated their first institution and started to receive their fellowship payments, the Board will seek to draw lessons from the experience of the first six months with an eye on both smoothening future expatriations and enhancing transparency between the partner organisations.

In terms of the research, the collective discussions on dissensus as well as the 16 individual research projects have started as scheduled. It has been a joy to see the fellows come into their own as they have taken the initial steps towards making both their individual research projects and the collective agenda their own. This year's annual conference is a crucial milestone for both of these dimensions. On the one hand, a Collective Conceptual Workshop will see the fellows, in conjuncture with the wider community, further elaborate a shared conceptual understanding of dissensus, contestation and competition surrounding Liberal Democracy in Europe. On the other hand, a day-long Doctoral Workshop will have the fellows for the first time present their individual research project to the wider community. The two main focal points of this year's annual conference are therefore: the shared conceptual references that bind the community, and the individual research agendas that propel its individual members forward.

With regards to the joint training, the first six months saw all fellows enrol and join the local doctoral training provisions at their primary institution. Here too local variations remain and are unavoidable. Nevertheless, repeated consultation between the partners has allowed for some uneven workloads to be ironed out within the confines of the respective national frameworks. As all fellows are presently settled into sustainable forms of year one training, the energies of the Board will shift towards formalizing the entire remainder of the training and evaluation calendar for each fellow via their Multiple Doctoral Degree Agreement. This will provide the fellows with the promised certainty

and predictability before the end of the first academic year. Besides the local provisions, the fellows have also enjoyed the project's first joint event: the 1st AGORA forum hosted by PATRIR in Cluj at the end of January 2023. With the Board gathering at the start of this year's conference, we look forward to assessing the outcomes of this first event as well as moving forward with the organisation of all other joint events scheduled between March 2023 and March 2024.

Lastly, a final component of this year's annual conference is its skills training effort which centres on relations with the media. Both a theoretical primer as well as practical exercises (in front of a camera) are foreseen over the course of a full day of sessions hosted at the Press Club Europe next to the main European institutions and led by skilled trainers and media professionals.

As you will have gathered, once again GEM-DIAMOND has put together a rich and demanding program for its members. We ask both our fellows and academic colleagues to bear with us as the Annual Conference's many moving parts are expected to all come together to provide both the individual fellows and the wider academic community with the necessary input to proceed with confidence towards its second year.

Please note that except for the Keynote all sessions on Monday (13.03) and Tuesday (14.03) have been set-up as hybrid. Those colleagues unable to attend in person are thus invited to join online (via TEAMS).

In the program you will find a dedicated TEAMS link for each session. The reference will include a shortened URL (which you are to copy past into your browser) as well as the meeeting ID and password either of which you can too access the sessions. FYI - we will launch each session 10-15 minutes before the scheduled starting time.



GEM-DIAMOND Doctoral Workshop

Individual Research Projects' Presentation

Objective

This day-long workshop will provide each of the 16 GEM-DIAMOND fellows with a chance to formally present their individual research project (IRP) to the community.

This closed-door doctoral workshop six months into the program, is a first (of many) opportunities to present their ongoing doctoral work.

In these early days of the maturation process of the different IRPs, the aim is neither to approve a final outline for each project, nor to grade the work accomplished so far. This is to be understood as a collective exercise encouraging the community to familiarize itself with the 16 ongoing IRPs and offer constructive feedback and guidance where possible.

As such, the purpose of the workshop is three-fold:

- 1. Encourage the fellows to start discussing their work with a range of interlocutors from accross the community, most notably their peers as well as the wide range of academics involved in the projects.
- 2. Breed greater familiarity between the different IRPs to help decompartementalize the individual research efforts. It is also a way for fellows to raise questions they might have or challenges they face in their research. The community and its various members collective mind can possibly provide useful advice or succour.
- 3. Provide a community platform as well as a regular milestone where and when fellows can publically present both their IRPs and their progress. This is to ensure all parties whether the co-supervisors or the Academic Board members are fully aware of where the different IRPs are at, as described by the fellows themselves

Overall Format

The workshop is organised as a series of panels structured along the 4 Work Packages (WP) which structure the GEM-DIAMOND workprogram.

Each session includes:

- A set number of short presentations by the fellows
- A chair who will keep time, sheperd the discussions, and act as the first discussant.
- A number of formal discussants who will jumpstart the exchanges. Selected across all discplines, they are either academics involved the project or GEM Alumni.
- A Question & Answer Time allowing for all audience members - whether in-person or online - to further the discussions.

The fellows' various supervsiors were all invited. While not all of them could attend, each of the 16 fellows will see at least one of their two-to-three co-supervisors participate in the workshop at one point. This participation can either be as a chair/discussant or as an audience member invited to contribute to the Q&As. audience

IRP Presentation Format

Each fellow will be given a 10min window to present their IRP. They are welcome to use any support materials they deem useful (e.g. PPT, a Hand Out, written materials, draft papers, ...). If they wish to use a PPT they are invited to provide a copy of the PPT at the latest a day before the workshop (13.03.23).

To make sure the include key information about their respective IRPs, guidelines were provide to help them in three ways:

- 1. Remind them of the original wording desscribing their IRP so they can better assess how it has evolved.
- 2. Make sure some fundamental features of their research agenda are touched upon (e.g. hypothesis, methodds, theory, case-study selection, ...).
- Invite the fellows to consider how their respective PhD research relates to the project's central concept of dissensus.

As these are guidelines they are ment to assits the fellows and as such fellows are not expected to hand in the answers to the suggested questions as such but rather have their presentation touch on these questions as they see fit.

Democracy, the Rule of Law and Fundamental Rights:

Their Decline and the EU Arsenal to Safeguard Them



Petra BÁRD

Professor at Radboud University, Research Centre for State and Law Associate Professor at ELTE School of Law, Research Affiliate at CEU Democracy Institute, Visiting Professor at Goethe University, Frankfurt.

The EU is founded on several values, which are reproduced by the Lisbon Treaty, in Article 2 TEU. From among these values democracy, the rule of law and fundamental rights stand out, they are overarching and mutually interconnected. These values are shared by the EU and its Member States, and the latter agreed to adhere and promote them when acceding to the EU and signing the Lisbon Treaty respectively.

In the first part of the presentation I will show that in the past more than a decade, some Member States are systematically destroying these values. Naturally, no state is entirely immune from values violations, but systemic problems are much more than a series of individual violations of the values, it is an orchestrated attempt to destroy all internal checks on government. The situation is severe. By now, the EU has Member States that are no constitutional democracies anymore. Were they to apply for EU membership today, they would be denied from joining the Union.

In the second part I will show that a violation of the rule of law in any Member State is an EU matter. Systemic breaches of Article 2 TEU values endanger the EU both as a Wertegemeinschaft and as a Rechtsgemeinschaft. A state's departure from the European consensus on rule of law and fundamental rights standards will have consequences beyond the borders of the given country and be detrimental and harmfu for the EU and EU law.

In the third part of the presentation I will show how a systemic value violation in some of the Member States directly affects mutual recognition-based instruments. Like canaries in a coal mine, they show from very early on the cross-border effect of rule of law decline. Mutual trust based instruments either become inoperative, or in case of EU institutions' insistence on applying them, Member States' courts might resist them, rather violating the principle of primacy than to contribute to a value infringement, especially a human rights violation resulting from cooperation with authorities of Member States that are hybrid or illiberal regimes


